The undersigned hereby agrees that Producer shall have the absolute and sole discretion in determining the extent and manner of the use of the Materials in the Series, and in the production, exhibition, distribution, exploitation, merchandising, marketing, publicity, and promotion thereof, and that Producer is not obligated in any way to use the Materials, or any portion thereof, in the Series or in any manner whatsoever.

The undersigned hereby represents and warrants that (i) the undersigned has the full right, power, and authority to enter into this Release and to grant the rights granted to Producer hereunder, and that no other consents, authorizations, or payments to third parties (including third parties appearing and/or contributing to the Materials), except those, if any, attached hereto, are necessary to permit the full use and enjoyment by the Producer of the rights granted hereunder; (ii) the undersigned is the owner and copyright holder of the Materials (or is an authorized agent of the owner and copyright holder); (iii) the Materials are not defamatory nor do they infringe on any trade name, trademark, or copyright of any person, firm or corporation; and (iv) the Materials do not invade or violate any right of privacy, personal, proprietary right, or other common-law or statutory right of any person, firm, or corporation. The undersigned shall, as may be requested by Producer, produce documents to establish or document the undersigned's rights in the Materials, including without limitation, copyright registration, releases for subjects in the Material, assignments or similar documents.

The undersigned hereby agrees that, as between the undersigned and Producer, all matter contained in the Series which can be copyrighted, trademarked, patented or otherwise deemed to have a proprietary interest protected by federal or common law now or in the future, and all elements and derivative thereof shall be the sole property of Producer, and the undersigned shall not have, nor will claim to have, either under this Agreement or otherwise, any right, title or interest of any kind or nature in or to any such material in the Series. The undersigned acknowledges and agrees that in the event of a breach of this Agreement by Producer or Producer's use of the Materials, the undersigned shall not have a right to seek injunctive, equitable relief, or to otherwise enjoin the development, production, distribution, exploitation, and advertising and publicity of the Series. The undersigned hereby acknowledges and agrees that this Release shall be binding upon and shall inure to the benefit of its successors, licensees, and assigns. Producer may sell, transfer, assign or otherwise dispose of its rights under this Agreement without the consent of the undersigned, in whole or in part, to any person, firm, or corporation. Nothing in this Agreement shall create any association, partnership, sponsorship or joint venture between the undersigned and Producer.
